



#### Assessment Conceptual Model

<u>Social determinants of health (SDOH)</u> are the conditions in the environments where people are born, live, learn, work, play, worship, and age that affect a wide range of health, functioning, and quality-of-life outcomes and risks.

- Neighborhood & Built Environment
- Health and Health Care
- Social & Community Context
- Education
- Economic Stability

Health equity will be achieved when everyone in the Region has equal and fair access to all the above resources.







Community Discussion Groups (CDGs) provide insights into community perceptions of issues and concerns, along with different approaches to solving local health problems



19 CDGs were convened for this assessment, with over 300 participants



#### Community Discussion Group Format

Each Discussion group was guided by the following questions

- 1. Describe your community.
- 2. What are the most important issue or challenges your community is facing?
- 3. What are the key resources in your community?
- 4. How has your community come together in the past to address important issues?
- 5. If a group were to try to address the issues you have identified, what advice would you have to help them be successful?
























# Poor Mental & Physical Health + Days

- There has been a notable increase in the number of poor mental & poor physical health days between 2013 and 2021 for the region.
- There has been a 22% (.8 days) increase from 2013-2021 in the number of poor physical health days for the region, and a 35% (1.2 days) increase in poor mental health days.

# Significant County Findings





#### Significant County Findings

#### Regional

- Friendly, traditional, developing
- Brazos County is a resource hub
- Rural counties have poor access to resources, jobs, and services
- Social isolation increased due to COVID-19
- Lack of affordable housing options
- Lack of healthcare providers in all fields across the Region

#### County-Specific

- Economic development in Burleson, Lee, and Leon Counties from the Samsung factory and Tesla factory
- Robertson County communities have expressed racial inequities that inhibit development across the county
- Milam County is remedying thier shortage of clinicians by increasing independent NP's locally

#### **Region Summary**

- Transportation has been identified as a top issue of concern in the Greater Brazos Valley Region since 2002
  - Transportation impacts accessing resources, healthcare, and entertainment
- Residents were concerned with the lack of jobs with livable wages in their home counties
- COVID-19 exacerbated health conditions across the Region
- Six of the nine counties have fewer than 50% of their residents who report living *reasonably close* to a location for physical activity

#### **Region Summary**

- Brazos County is seen as a regional hub for the rural counties for a variety of services
- Lack of communication to residents of available resources across their counties
  - Better communication between non-profit organizations, government programs, and residents
- Communities feel underprepared for extreme weather events, disaster response, and future pandemics
